Melvin Carter is a fourth-generation Saint Paulite and son of Ramsey County Commissioner Toni Carter and former police officer and nonprofit leader Melvin Carter Jr. He holds a bachelor's degree in business administration and a master's degree in public policy. Melvin served as Ward 1 Saint Paul City Councilmember from 2008-2013.

He is most proud of his work as a councilmember to secure two additional light rail stops on the Green Line, establishing the city's Affordable Housing Trust Fund and Department of Human Rights and Equal Economic Opportunity, and founding Saint Paul's Promise Neighborhood.

Melvin left office in 2013 to serve as the Executive Director of Governor Mark Dayton's Minnesota Children's Cabinet, where he oversaw greater investment in higher per-pupil funding, all day kindergarten, and an expansion of Pre-K programs across the state.

Melvin has a long history of organizing which began in 2000, when his brother-in-law was turned away from casting a ballot in the presidential election in Florida.

If elected, Carter's priorities for Saint Paul include: raising the minimum wage, improving outcomes for kids in public schools, increasing access to affordable housing, enacting smart policing reform to rebuild the trust of all our neighbors, and building a city that works - for all of us.

Tom Goldstein grew up just outside of Washington D.C. He moved to Minnesota in 1975 to attend Carleton College and has been a resident of Saint Paul since 1984 where he currently lives in the Hamline-Midway neighborhood. A graduate of the William Mitchell College of Law, Tom operated the Sports Collection retail store on Grand Avenue for many years and is a former member of the Saint Paul School Board. He has also been a long-time advocate for neighborhoods and has served on the Mac-Groveland Community Council, the Ayd Mill Task Force, and as chair of the JJ Hill Montessori PTO. His "people before politics" message is exemplified by his well-known opposition to public subsidies for sports stadiums.

Tom is running for mayor to change the status quo in Saint Paul and ensure that local government works for residents rather than just political insiders and wealthy developers. Since then, he has been an IT professional and found his way into community organizing through his faith and pursuit of justice. He organized with ISAIAH and TakeAction Minnesota prior to being elected to the City Council in 2013. As mayor, some of his priorities include: investing in families and safe neighborhoods by increasing affordable housing, championing all day pre-kindergarten and making sure police and fire departments have the resources they need to succeed while improving police-community relations, working toward greater equity by prioritizing investments in ignored communities, supporting a \$15 minimum wage, and encouraging entrepreneurship.
