LWVSP YOUTH VOTE TEAM

The LWVSP Youth Vote Team has two new projects focused on working with high school students as leaders in St. Paul voter engagement and voter registration efforts. The first is our own LWVSP *Student Leader* program. The second is LWV Minnesota's *Fellowship* program. So far we are working with 12 highly engaged high school students in four schools in St. Paul and growing every week!

LWVSP's Student Leader program is now focused on four high schools on the short list for Spring 2019: Focus Beyond, Harding, Johnson, and St. Paul Conservatory for Performing Arts (SPCPA). LWV Minnesota's Fellowship program is up and running. Five Central High School student Fellows are active and three Fellows are active at Como High Schools.

“START BY BELIEVING” PANEL

LWVSP’s “Start by Believing” panel was a thought-provoking and interesting event. Special thanks to our speakers who each brought their unique insights to the issue of sexual assault response and prosecution:

Sarah Colford, a survivor and Board Member and Moderator for Break the Silence, an organization that works to support survivors of sexual violence by striving to end rape culture and hold perpetrators accountable;

Jennifer Bjorhus, an Investigative Reporter for The Star Tribune who authored the “Denied Justice” series examining how Minnesota’s criminal justice system often fails victims of rape and sexual assault;

Commissioner Paul Schnell served on the Minnesota Peace Officer Standards and Training (POST) Board from 2014 to 2017 and is currently the head of Minnesota’s Department of Corrections.

Nicole Matthews, an Anishinabe from the White Earth Band of Ojibwe who serves as Executive Director for Minnesota Indian Women’s Sexual Assault Coalition;

John Choi, the Ramsey County Attorney whose innovative approach to working collaboratively with advocacy agencies to help victims has transformed the way government intervenes in domestic violence and sex trafficking situations.

“MONEY IN POLITICS: RESTORING FAIR REPRESENTATION TO THE PEOPLE”

Minnesota ratified the amendment in September, and by August of 1920, it was adopted by all the required states. To mark the opening of the LWV Minnesota Centennial Convention, take a special tour that focuses on Minnesota women who played significant roles in securing the right to vote. Learn about the struggles and success stories of Minnesota women who worked to convince elected officials in the State Capitol to grant women the vote. Plus, learn about the first elected women to take office in Minnesota, what role they played in state government, and how women today participate in elected office.
